2. **2023** Legislative Update

Chief of Staff Tiffany Shireman provided an overview of the NCSD Legislative Agenda, reported on the 2023 Oregon Legislative Session and answered questions from the committee.

Assistant Superintendent of Education Ivonne Dibblee provided an introduction to the Instructional Report and provided information on ESSER III funding – Unfinished Learning with Executive Director of Elementary Programs Khaliyah Williams-Rodriguez and Associate Director of Secondary Programs & Athletics Ryan Richardson and answered questions from the committee.

Executive Director Teaching, Learning, & Professional Development Tammy O'Neill shared an overview of North Clackamas School District curriculum adoption stages and federal programs, and answered questions from the committee.

Director of Integrated Programs Jennifer Dove-Kiltow provided on overview of Integrated Programs.

4. ESSER Funds Report/Budget Update

Director of Fiscal Operations Dawna Burke provided an overview of the planned use of the remaining ESSER funds for the 2023-2024 school year.

Executive Director of Finance & Business Services Matt Makara reported that there were no significant updates to the financial forecast. The next budget update from the state will be announced on May 17th.
